SECTION 1 A:- PROCEDURE FOR SUBMISSION OF E-TENDER

The bidders are required to submit soft copies of their bid electronically on the e-Wizard Portal using valid Digital Signature Certificates. Detailed Specification for Laser Shock Peening Setup

1. Laser Wavelength: 1064 nm

2. Pulse energy: ≥ 650 mJ@1064 nm

3. Pulse width (ns): 9-12 ns @ 1064 nm

4. Beam diameter: ≤ 9 mm

5. Divergence: ≤ 0.8 mrad

- 25. The system should have a warranty of 1 year from the date of installation. The supplier should also quote for one year extended warranty in their offer. The supplier should also mention the cost of 'Annual Maintenance Contract' per year after the standard warranty of the Laser in the commercial bid.
- 26. The Laser system should be delivered and installed at NIT Karnataka within 12 weeks or less after the PO release.
- 27. The supplier should also provide two Laser safety goggles with the system
