- 2. The bidder shall be OEM/authorized partner/ service provider of the OEM.. In case the bidder is an authorized partner or service provider, a valid partnership/ dealership certificate (MAF specific to this tender) to quote on behalf of OEM should also be enclosed along with technical bid
- 3. The Indian agent or SI and the Principal manufacturer (OEM) cannot bid simultaneously
- 4. One Server OEM can authorize only one SI/Bidder to quote their products
- 5. Bothe Bidder and OEM should be listed in each Top Supercomputers in India list published since last three years
- 6. Bidder must not be blacklisted by any Govt. Organisation in India; a notarised declaration must be submitted with the bid
- 7. Bidder must be ISO 9001, ISO 14001, ISO 27001 Certified Organization. The Certificates to be submitted along with the bid
- 8. Bidder/OEM should be Registered with Bureau of Indian Standard and EPR (for E-Waste) as per Govt Regulations
- 9. On Site support to be provided by the Bidder or the OEM. Declaration to be submitted along with the bid
- 10. Bidder must have minimum annual sales turnover of Rs. 50 Crores for each of last three financial years. The copy of Balance Sheets/ Certificate from CA towards certification of turnover for last three years to be submitted along with the bid
