Instructions to the candidates:

The following candidates are required to report online at NITK admission portal during 7th to 13th DECEMBER, 2021 for completing the admission formalities

1. All the candidates who have been allotted a seat for B Tech Programme in NITK Surathkal in JoSAA Rounds and have secured their seat at NITK by paying the Partial admission fee during 20-24 November 2021 at the JoSAA portal

OR

2. Those candidates who may be allotted a seat for B.Tech Programme in NITK Surathkal in CSAB Special Rounds 1 and 2, and have secured their seat at NITK by paying the Seat Acceptance fee in CSAB Portal

Due to the pandemic situation, the admission of the candidates at NITK would be online.

The candidates are not required to report at NITK for online admission during 7th to 13th, December, 2021.

All the candidates who have secured a Seat at NITK after payment of applicable fees at JoSAA or CSAB portal will be sent the login credentials for the admission portal of NITK through the email id registered in the JoSAA/CSAB portal. The online Admission portal of the Institute will be made live from December 7, 2021 (Tuesday) to fill-up the Online Admission form, upload documents and to pay the balance Institute fee and Hostel fee.

Candidates are advised to fill their details through the NITK IRIS portal by logging in, at the MIS link <https://iris.nitk.ac.in/admission/admissions/login> and upload the documents listed below and pay the balance Institute and Hostel fee at the IRIS portal for admission at the institute. The details of the fee to be paid are given below. The online document verification by NITK officials will be carried out during 7 - 13 December 2021 and Provisional Admission Orders will be issued to the candidates online.

During the document verification, candidates may be contacted by email, if there is any query on the uploaded documents. The candidates are required to check their email frequently during this period and respond to the query accordingly.

The First Semester classes would Commence from 27th December 2021 and would be held in online mode. The Academic Calendar is available in the Institute website .

Hostel Facility

Hostel facilities are available for all the students. Hostel Room Allotment will be done to the admitted students whenever they are physically present at the Institute and after payment of required hostel fees.

Documents to be uploaded

1. Provisional admission letter downloaded from the JoSAA portal, after paying the partial admission fee, between November 20 – 24, 2021 or that downloaded from CSAB portal after payment of seat acceptance fee as applicable.
2. Score Card of JEE (Main)
3. Admit Card of JEE (Main)
4. Photo ID proof as per Govt. of India norms (Copy of Aadhar Card is compulsory)
5. Original Certificate of Date of Birth issued by competent authority/Class X (High School) Board Certificate as proof of date of birth
6. Original Mark sheet of Class XII
7. Medical Certificate in JoSAA format/NITK format.
8. Original Certificate of category (OBC-NCL/SC/ST), if applicable, as per Government of India, issued by the competent authority. In case of OBC category, the certificate must be issued on or after April 1, 2021.
9. OBC Undertaking in the format available in NITK Website

10. Original Income and Assets Certificate for EWS candidates, if applicable, as per Government of India, issued by the competent authority. The certificate must be issued on or after April 1, 2021.
11. Original Certificate for Persons with Disabilities (PWD), if applicable, issued by the competent authority and the physical verification report issued by any verifying center during JoSAA Rounds.
12. Original Migration certificate of last institute/university attended (If from outside Karnataka)
13. Original Conduct/Character Certificate from head of the institution last attended
14. Original Transfer certificate from the head of the institution last attended
15. Passport size photograph.

(If any certificate is in language other than Hindi or English or Kannada, translation of the same in English is to be produced with certification by the competent authority).

Important Note:

- (1) *Candidates belonging to OBC –NCL or EWS category are required to submit the certificates in the prescribed format available in the NITK website (i.e. www.nitk.ac.in) or in JoSAA portal and issued on or after April 1, 2021*
 - (2) *Caste certificate (SC/ST/OBC-NCL) issued by Maharashtra State must be validated by Social Welfare department (in case of SC and OBC-NCL category) and Tribal Welfare department (in case of ST category) of Maharashtra Government. The SC/ST/OBC-NCL candidates of Maharashtra State have to produce their caste validity certificate in the format available in the NITK website (i.e. www.nitk.ac.in).*
 - (3) *The candidates who belong to PWD category must submit the certificate issued from a competent authority in the prescribed format.*
