**B. Tech Admissions 2022-23 through JoSAA-2022**  
**Online Payment of Partial Admission Fee (PAF) at JoSAA portal**  
*(After completion of Round 1 to 6)*

**Instructions to the candidates:**

All the candidates who have been allotted a seat for B Tech Programme in NITK Surathkal and have accepted the same in ROUNDS 1-6 under JoSAA - 2022, are hereby required to complete the following steps after completion of 6<sup>th</sup> Round of JoSAA-2022.

As instructed by CSAB -2022 the candidates who have accepted an allotted seat at NITK Surathkal in ROUNDS 1-6 under JoSAA -2022 **and wish to retain their allotted seat, are required to pay the Partial Admission Fee (PAF) online from their JoSAA portal only during October 19 to October 21, 2022 (17:00 Hrs) to secure the admission.** As communicated by CSAB - 2022, the partial admission fee is as follows:

**Amount:**

- ₹40,000/-: GEN/OBC-NCL/GEN-EWS Category Candidates
- ₹20,000/- : SC/ST/PwD Category Candidates
- ₹60,000/- : Candidates whose categories changed from SC/ST category to GEN category or from PwD to Non-PwD status during Online Document Verification. This amount includes the differential amount ₹20,000/- between SAFs of their updated GEN/OBC-NCL/GEN-EWS status and the earlier SC/ST/PwD status.

**Mode of Payment:**

- UPI / Net Banking / Debit card / Credit card facilities available on the JoSAA portal upon login.
- E-challan of State Bank of India downloaded from the JoSAA portal upon login.

The candidates are hereby informed to visit the JoSAA -2022 website for more details on the payment of partial admission fee and instructions on reporting at the JoSAA portal.

As instructed by CSAB-2022, Non-payment of the Partial Admission Fee (PAF) within the stipulated time will be treated as a rejection of the offered / allocated seat by the candidate. In other words, if a candidate fails to pay the Partial Admission Fee (PAF) within the above stipulated time ,she/he will forfeit the provisionally allocated seat.
