

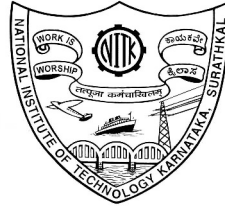

NITK Hostel trust is looking after NITK Hostel activities.

The NITK, Surathkal Hostels intends to purchase the 50” Smart TV (7 no's) for NITK Hostel Blocks. In this connection, sealed **Quotations** are invited by the undersigned subject to the terms and conditions enumerated hereunder from the manufacturers/ authorized dealers/ agencies **so as to reach this office on or before 21.12.2022 by 4:00 PM**. The quotation shall be opened on a later pre-informed date.

**Scope of Work:**

1. Supply of specified TV with stand, terminal connecting and installation.
2. The periodic maintenance is to be carried out at regular interval like every quarter of the year upto warranty period (3 years).
3. If any breakdown occurs during warranty period is to be attended within 12 hours.

**Terms and conditions:**

1. The intending bidder shall quote his rates and he shall sign each page with seal of the firm. Envelope super scripted as “**Quotation for supplying 50” Smart TV; Due on 21.12.2022**”. and addressed to as “ NITK Hostel Office, First floor, Sahyadri Hostel Block building, NITK, Srinivasnagar, Mangaluru – 575025.” Be sent so as to reach this office on or before the due date mentioned.

2. The GST registration number and the PAN number of the bidder shall be mentioned in the quotation.
3. Quotation may be dropped in the Tender Box kept in the office or may be sent by post/ courier. It is the responsibility of the bidder to make sure that the quotation is delivered in time. The quotations received after the due date will not be entertained.
4. GST rate as applicable shall be mentioned clearly.
5. The rate quoted shall be valid for 90 days for its acceptance.
6. The quotation/ bid shall be accepted as a whole or parts thereof depending on the lowest rate quoted for individual items. The bidder shall supply the TV accordingly.
7. The TV should be supplied within 10 days from the date of confirmation of acceptance of the quotation.
8. The TV supplied should be strictly as per the specifications specified, without which the TV will be rejected.
9. In case of rejection of TV, one more chance shall be given for its replacement with the material conforming to the specification specified. Failure to supply the TV as per the specification will result in debarring the bidder for participation in bids for a minimum of one year.
10. No advance payment will be made. The payment shall be made through NEFT/Bank transfer on receipt of materials in good working condition. No interest will be made for delayed payment if any.
11. The rate quoted should be firm. No claim for enhancement of rate is admissible after opening of the Quotation.
12. Terms and Conditions stipulated in this Notice Inviting conditions are binding on the bidder. Quotations with conditions in contrary to this NIQ are liable for rejection.
