3. Quotation may be dropped in the Tender Box kept in the office or may be sent by post/ courier . It is the responsibility of the bidder to make sure that the quotation is delivered in time . The quotations received after the due date will not be entertained .
4. GST rate as applicable shall be mentioned clearly .
5. The rate quoted shall be valid for 90 days for its acceptance .
6. The quotation/ bid shall be accepted as a whole or parts thereof depending on the lowest rate quoted for individual items . The bidder shall supply the Table Tennis Board accordingly .
7. The Table Tennis Board should be supplied within 10 days from the date of confirmation of acceptance of the quotation .
8. The Table Tennis Board supplied should be strictly as per the specifications specified, without which the Table Tennis Board will be rejected .
