- 1. Qualification: Ph.D./ Master's Degree (M.E./ M.Tech. or equivalent) holders with first class in respective discipline and GATE qualified candidates preferred.
- 2. The age limit for the candidate is 60 years.
- 3. Consolidated Pay:
  - a) For those with Ph.D. Rs.50,000/- per month.
  - b) For those with a Master's Degree (M.E./ M.Tech. or equivalent) Rs.40,000/- per month.
- 4. No other allowances are admissible.
- 5. Nature of appointment: The appointment is purely temporary for one semester.
- 6. The interested candidates have to attend walk-in-interview along with a filled-up application form and self-attested necessary documents (Original & Xerox Copy).
- 7. Reservation will be as per Government of India Norms.
- 8. If applicable, the candidates are required to enclose their valid Community Certificate in the prescribed format.
- 9. The selected candidates will be required to join immediately.
- 10. Canvassing in any form will render a candidate ineligible.
