With reference to the subject mentioned above, those Research Scholars with Institute Fellowship who have joined prior to Academic year 2020-21, and who were sanctioned H.R.A earlier for the period from 1-7-2022 to 31-12-2022, with permission to stay outside may submit dully filled claim form, rent agreement copy (rent agreement signed on or before the date of occupying the rented properties, and rent agreement should be in force for the duration of the stay)and undertaking form available in the Institute website to claim H.R.A for the period from 1-1-2023 to 30-6-2023. All the relevant documents to be submitted to the Academic Section on or before 12-6-2023. If the documents are not in proper order, their request for H.R.A re imbursement will not be considered. All such reimbursement of H.R.A will be considered only if the payment is made through Digital Transaction.

As per N.I.T.K Notification dated 31-1-2022, the Un-married Research Scholars who were drawing H.R.A earlier until 30-6-2021, are not eligible for reimbursement of H.R.A from the academic year 2022-23.
