**Instructions to the provisionally selected candidates for M.Tech (Research / Sponsored) admission 2024-25**

1. The provisional Admission offer letters are being sent individually by email on June 7<sup>th</sup>, 2024 (Friday).
2. Candidates provisionally selected for the M.Tech (Research/sponsored) should take admission during **working days (Monday to Friday) between June 10<sup>th</sup> to June 14<sup>th</sup>, 2024** otherwise they would be forfeiting their seat to candidates in the Wait-list.
3. Candidates should be **personally present for the admission. Physical presence of the candidates is mandatory**. Under no condition admission can take place through a representative or through proxy.
4. An Admission portal will be made active from June 7, 2024 (Friday) to fill-up the Admission form for all those candidates who have been provisionally selected M.Tech (Research/sponsored) programme at NITK. The candidates are advised to login to the admission portal in the IRIS (link <https://iris.nitk.ac.in/admission/admissions/login> using M.Tech(Research/sponsored) **application credential**, fill in the required details and upload the documents listed below (scanned copies of the original) for admission to the institute and pay the prescribed Institute Fee for admission to the institute. The candidates are directed to pay the fee online in IRIS portal (Payment link will be available on IRIS portal between 07.06.2024 to 14.06.2024). The candidates are required to complete all the above activities before reporting physically for admission at NITK Surathkal.

**The date of commencement of classes will be announced later.**

**The scanned copies of the following Original documents are to be uploaded by the candidate at the IRIS Admission portal and to be submitted in original along with one set of photo copies:**

1. Provisional Admission offer letter issued by competent authority.
2. Original GATE/NET score card (if applicable)
3. Photo ID proof as per Govt. of India norms (Copy of Aadhar Card is compulsory)
4. Original Certificate of Date of Birth issued by competent authority/Class X (High School) Board Certificate as a proof of date of birth.
5. Original Mark sheet of Class XII
6. Original Grade/Mark sheets of qualifying examination (UG) for all the semesters
7. Original Degree / Provisional certificate for UG, if degree is completed
8. Original Course completion certificate from the Head of the University/Institute, if result is awaited
9. An Undertaking by those candidates whose result is awaited (Annexure II)
10. Original Certificate of category (OBC-NCL/SC/ST), if applicable, as per Government of India, issued by the competent authority. In case of OBC-NCL category, the certificate must be issued on or after **April 1, 2024**
11. Original Income and Assets Certificate for EWS candidates, if applicable, as per Government of India, issued by the competent authority. The certificate must be issued on or after **April 1, 2024**.
12. Original Certificate for Persons with Disabilities (PWD), if applicable, issued by the competent authority.

13. Undertaking to be submitted by OBC-NCL candidate in the format provided (Annexure I)
14. Sponsorship certificate and No objection certificate (for External Registrants, Full time sponsored candidates and Internal Registrants in the prescribed format)
15. Relieving Certificate in the case of full time Sponsored Candidates
16. Passport size photograph.
17. Medical fitness certificate
18. Original Conduct Certificate from head of the institution last attended
19. Original Migration certificate of last institute/university attended
20. Original Transfer certificate from the head of the institution last attended

**(If any certificate is in language other than Hindi or English or Kannada, translation of the same in English is to be produced certified by the competent authority)**

## 5. Hostel Facility

Hostel facilities are available for all the students. Hostel Room Allotment will be done to the admitted students at the time of physical reporting to the Institute.

### Important Note

- (1) Candidates belonging to OBC -NCL or EWS category are required to submit the certificates in the prescribed format available in the NITK website (i.e. [www.nitk.ac.in](http://www.nitk.ac.in)) and issued on or after April 1, 2024. The certificates issued earlier than the prescribed date is not acceptable and no affidavit or undertaking in this regard will be acceptable during the admission.
- (2) Caste certificate (SC/ST/OBC-NCL) issued by Maharashtra State must be validated by Social Welfare department (in case of SC and OBC-NCL category) and Tribal Welfare department (in case of ST category) of Maharashtra Government. The SC/ST/OBC-NCL candidates of Maharashtra State have to produce their caste validity certificate.
- (3) The candidates who belong to PWD category must submit the certificate issued from a competent authority in the prescribed format available in the NITK website (i.e. [www.nitk.ac.in](http://www.nitk.ac.in)). They also need to submit an undertaking along with the certificate. The prescribed format for the undertaking may be downloaded from the NITK website.
- (4) The candidates whose examination for Bachelor's degree study has not been completed or who are awaiting for their result, must submit a Course completion certificate duly signed by the Head of their Institution in the prescribed format. The prescribed format is available in the NITK website. **A self-declaration in this regard is not acceptable.** Such candidates should also submit an undertaking in the prescribed format available in the NITK website along with the course completion certificate.
- (5) The candidates who do not have or are not able to get the conduct certificate, transfer certificate and migration certificate presently may submit the same at a later date after reporting. However, such candidates may write a request letter to Dean (Academic), stating the reason for not submitting these certificates and upload the same on the IRIS portal. However, all the other listed documents (as applicable) are to be submitted without fail.
- (6) The candidates who have been selected under full time sponsored or External Registrant- sponsored category must submit the sponsorship and No objection certificate from the sponsoring organization in the prescribed format available in the NITK website.
- (7) The candidates who have been selected under Internal registrant -NITK category must submit a sponsorship-cum-clearance certificate from the Dean (R&C), NITK.
