Call for Applications for Financial Assistance for the Academic Year 2024-25

The SC/ST Cell invites applications in the prescribed format from eligible regular full-time SC/ST students pursuing **B.Tech./M.Tech./MCA/MBA/M.Sc./Ph.D. degrees** for financial assistance for the academic year 2024-25.

Important Dates

The **last date** for submission of completed applications, along with all necessary enclosures, is **4th February 2025**.

How to Apply

- Download the application and undertaking forms from the Institute website: <u>https://www.nitk.ac.in/Scholarships</u>.
- Submit the completed application form with all required documents at the **SC/ST Cell office** before the deadline.

Eligibility Criteria

- 1. **Family Income**: The annual family income of the student should be less than **₹4.5 Lakhs**.
- 2. **No Concurrent Scholarships**: The student must not be receiving any other scholarships from state/central government, PSUs, or private organizations. A declaration to this effect must be submitted.
- 3. Academic Performance:
 - For **B.Tech./MCA/MBA/M.Sc. students**: A minimum CGPA of **5.0** up to the previous semester is required (not applicable for 1st-semester students).
 - For **Ph.D. students**, there is no minimum CGPA requirement.

Types of Financial Assistance Available

For B.Tech./MCA/MBA/M.Sc. Students:

- 1. Reimbursement of actual hostel and mess fees paid at NITK Hostels Office.
- 2. Reimbursement of **hostel room rent** paid to the institute.
- 3. Laptop Assistance: One-time support of up to ₹45,000 for purchasing a laptop.
- 4. Books and Stationery Assistance: Up to ₹6,000 per year for academic resources.
- 5. Academic Performance Incentives:
 - **₹18,000** for CGPA between **8 and 10**.
 - **₹12,000** for CGPA between **6.5 and 8**.

For M.Tech./Ph.D. Students:

1. Laptop Assistance: One-time support of up to ₹45,000 for purchasing a laptop.
