Sub: Application for the award of Merit -Cum -Means Scholarship to 1st Year B. Tech. students for the Academic year 2024-25 reg. Ref.No. 1) NITK/Sch/2024-25/E4 dated 21.01.2025.

In continuation of this office circular vide reference cited (1) above, this is to inform to all the 1st year B.Tech students that, applications for the award of Merit-Cum-Means scholarship is being called for the Academic Year 2024-25.

I. Criteria for Award of scholarship: -

- 1. Merit –cum-Means Scholarship will be awarded in the institute every year to top 50 meritorious students in the order of merit based on JEE (Main) All India Rank, subject to the condition that their parents income is < 4.5 Lakhs and they should have ≥ 70% marks at 10+2 level or equivalent qualifying examination.
- 2. Students admitted under DASA, ICCR, MEA are not eligible for scholarship.

II. Merit -cum-Means Scholarship

- a. Continuation of the scholarship in subsequent years will be based on the academic performance, parent's income and conduct of the scholars.
- b. Merit-cum-means scholarship awardee is eligible to continue his scholarship if his parent's income is < Rs. 4.50 lakhs and has secured a CGPA of \ge 7.0 at the end of the preceding academic year.
- c. When a scholar doesn't meet the eligibility criteria for the continuation of scholarship in the subsequent years then his scholarship will be suspended for one academic year and will be renewed if he attains the eligibility requirement in the following academic year. This concession will not be extended beyond one academic year, during the entire course.
- d. In case a student secures I/FF grade in any course during an academic semester and gets a passing grade in the subsequent make up examination then he is eligible for continuation of scholarship. If the student does not get passing grade in the make-up examination then his scholarship will be terminated.
- e. In case a student secures FA grade in any course then his scholarship will be terminated.
- f. If the earning parent of the Merit scholarship holders dies, or his income

is permanently reduced owing to retirement or other unforeseen circumstances, the scholar and the family annual income is reduced to less than Rs. 4.5 lakhs then he may be considered for the award of Merit-cummeans scholarship subject to the availability. This benefit will be admissible from the month in which such a situation occurs and will be available till the completion of the particular stage of study provided the scholar fulfills other conditions. For this purpose the parent/guardian of the scholar should submit fresh Income Affidavit which should be duly supported by documentary evidence.

The students who are willing to apply for "Merit Cum Means Scholarship" are informed to download the application form from the Institutes webpage, i.e. www.nitk.ac.in. Forms duly filled in all respect with necessary documents and filled application form (Hard Copy) can be submit to E4 Asst. Academic Section on or before 24.02.2025. No application will be entertained after due date. The amount of scholarship for Merit Cum Means Scholarship is Rs. 2000/- per month per candidate.
