The Board was informed that as per BoG resolution (Item No 77.3.3) an advertisement for 100 faculty positions across 14 departments was published on 27th July 2024 (No.: 5210-Advt./Faculty-NITK-Estt./ 2024/B1). The Board was appraised about the vacancies, number of applications received, and other details. The entire process was conducted in accordance with NITSER Act 2007, First Statutes, Amendment Statutes and Recruitment Rules issued by MoE. The selection committee was constituted as per the NIT (Amendment) Statutes, 2017. The experts were drawn as per BoG resolution (Item No. 77.3.4). The list of Selection Committee members (Visitors nominees, Senate nominees, Board nominees and Observers) for all the departments were also placed before the Board.

The Board went through the selection list, and deliberated on the recommendation of the Selection Committees. Decision regarding the recommendation of the Selection Committee for Associate Professor in the Dept. of Mechanical Engineering, for which Dr. Arumuga Perumal, an internal applicant, was the sole candidate, and who was issued a showcase notice (as resolved in BoG item No. 76.3.1), was deferred to the next meeting of the BoG.
